AGREE REALTY CORPORATION ANNOUNCES MIDLAND, MICHIGAN DEVELOPMENT PROJECT

FARMINGTON HILLS, Michigan (October 15, 2004) - Agree Realty Corporation (NYSE: ADC) today announced that it would develop, for retail use, a property that it has acquired in Midland, Michigan.

The Company's budgeted cost for the project is \$4,200,000. The project is pre-leased and is expected to be completed during the second quarter of 2005.

Agree Realty Corporation is engaged in the ownership, management and development of properties, which are primarily single tenant properties leased to major retail tenants and neighborhood community shopping centers. Agree Realty owns and operates a portfolio of 52 properties, located in 14 states and containing 3.4 million square feet of leasable space.
